Vendor Table Reservation Policy

6-1-2019

1. All table reservation, for All venues, require a deposit of at least 50% at time of reservation being placed. Or prepayment in full if so desired by the vendor. Payment may be by credit card, check, cash.
If a vendor **has not made a reservation**, and required deposit, although they may be a regular at the venue, they will take **a chance of losing their usual floor location**. **PAID RESERVATIONS HAVE PRIORITY AND WILL BE PLACED IN THE GUN SHOW ACCORDINGLY**. No exceptions.
2. There are no refunds on table reservations. WE understand things and emergencies happen in life. Vendors are permitted to roll reserved tables at a venue to the next date for that venue that is on the schedule. Rolling reserved tables to a different venue is not permitted. A vendor is permitted to roll reserved tables **ONE TIME ONLY** per any yearly show schedule per venue.
3. Any vendor needing to roll reserved tables must do so 2 weeks before scheduled show date. Any vendor emergency will be addressed on a case by case basis under the 2 week requisite time frame.
4. Load in at ALL VENUES is 12:00 noon Friday (no Earlier unless authorized before by management), until 8:00 pm. Load in on Saturday morning is 7am until 8:30am. If a vendor is running late for any reason, if they do not notify The Real Texas Gun Show management before opening of the gun show run the risk of not having a table. Any vendor not accounted for by 830am morning of the show opening, any reserved tables will be covered by other nearby vendors and said tables and deposits will be forfeited.
5. All shows end at 4:00 pm Sunday afternoon. Load out may begin after all patrons have exited the building and must be completed no later than 6:30pm Sunday. **ALL VENDORS SHALL LEAVE THEIR AREA CLEAN OF ALL TRASH AND DEBRIS!** Any vendor leaving their area not cleaned up shall be charged an additional 20.00 and payable before attending any shows in the future of The Real Texas Gun Show.
6. ANY vendor loading out without prior authorization at any venue will **not** be allowed to reserve tables at the next scheduled show at that venue
7. Vendors may request a specific floor location at a venue at upcoming dates. **IF THE LOCATION IS WITHOUT RESERVATION** at the close of that show date, and the requesting vendor makes the required deposit, that specific location will then be the requesting vendors location at the upcoming next show at that venue.
8. If any table location or reservation come into dispute between vendors, **THE REAL TEXAS GUN SHOW** management will make the vendor placement. Management decisions are final. Management reserves the right to move any vendor to a new location at their discretion and judgment if it would benefit the overall show appearance.
9. The Real Texas Gun Show management reserves the right to remove any vendor from the show, refuse service to anyone, solely at their discretion.
10. **THERE ARE TO BE NO LOADED FIREARMS ON THE GUN SHOW FLOOR. ALL WEAPONS MUST BE UNLOADED BEFORE ENTERING THE BUILDING NO EXCEPTIONS. THE REAL TEXAS GUN SHOW PROVIDES NYLON ZIP TIES AND ALL WEAPONS MUST BE SECURED AND TEMPORARLY DISABLED BEFORE THE SHOW OPENS TO THE PUBLIC.** Any weapon found not secured after the show opens will be confiscated until the end of the show. If I really like the unsecured weapon, I may decide to keep it.
11. Any weapon found with ammunition in the magazine and especially in the chamber will be grounds for immediate removal of that vendor from the show. Any accidental discharges by any vendor or their staff is grounds for immediate removal, all necessary law enforcement reports made and filed, Vendors are financially responsible for any damages to the venue or persons if injured and will be barred from The Real Texas Gun Show and will notify other promoters of the incident.
